For the purpose of providing information to the health department or the local police authority, we collect and save the following guest data:

- Surname and first name of the guest
- Date (start and end of the visit), and
- Telephone number or address of the guest

The legal basis for this is Article 6 Paragraph 1 Letter c) of the General Data Protection Regulation (GDPR) in conjunction with § 2 Paragraph 4 Corona ordinance on accommodation establishments (ordinance to contain the transmission of the corona virus (SARS-CoV-2) for accommodation companies from May 23, 2020).

In the case of a specific suspicion of infection, the responsible health authorities or local police authorities are the recipient of this data. Your personal data will be deleted by **after four weeks**.

You are not obliged to provide your personal data; the correctness of your information will also not be checked by the operator of this accommodation company. However, if you do not provide us with your personal data, you must not visit our hotel.
